In connection with the signing [on this date] of the Trans-Pacific Partnership Agreement (the "TPP Agreement"), I have the honour to confirm the following agreement reached between the Government of Australia and the Government of Vietnam (the "Parties") during the course of negotiations on the TPP Agreement:

- 1. Without prejudice to paragraph 2, the Parties agree to terminate the "Agreement between Australia and the Socialist Republic of Vietnam on the Reciprocal Promotion and Protection of Investments", signed in Canberra on 5 March 1991, (hereafter the "IPPA"), on the date of entry into force of the TPP Agreement for both Vietnam and Australia (the "date of termination").
- 2. The IPPA shall continue to apply for a period of five years from the date of termination to any investment (as defined in Article 1(1)(a) of the IPPA) which was made before the entry into force of the TPP Agreement for both Australia and Vietnam with respect to any act or fact that took place or any situation that existed before the date of termination.
- 3. A claim under Article 12 of the IPPA (Settlement of disputes between a Contracting Party and a national of the other Contracting Party) may only be made within three years from the date of termination and only with respect to any act or fact that took place or any situation that existed before the date of termination.
- 4. The Parties agree that the provisions for termination of the IPPA contained in this letter shall, at the date of termination, supersede the provisions for termination contained in Article 15 of the IPPA.

I have the honour to propose that this letter and your letter of confirmation in reply shall constitute an agreement between Australian and Vietnam which shall enter into force on the first date on which the TPP Agreement is in force for both Australia and the Socialist Republic of Vietnam.
